1. A minimum deposit of \$1050 is due within 72 hours of acceptance to Emerging Sprouts to hold my child’s spot. I will submit my next payment, which is dictated by the plan I choose below (Option A, B, or C).

Option A: One payment for the entire school year semester fees.

Option B: 3 payments for the school semester tuition fees.

Option C: Monthly payments (\$35 monthly payment fee).

Online Bill Payment Check’ set up through your bank. (This is set up with your bank. They will mail a “bank check” by the 15th of every month to our address).

2. I understand that, though tuition can be paid in multiple installments, this does not constitute a fractional or month-to-month contract. After signing and returning this Enrollment Agreement, any cancellation or withdrawal would be subjected to liquidated damages, as follows:

- After signing this agreement, I have 3 days (72 hours) to request a full refund of my first payment. After 72 hours have passed, should I choose to unenroll, I will forfeit my first payment.
- Should I choose to unenroll after 4 days, I understand that I am also financially responsible for an additional percentage of my child’s annual tuition, dependent on my unenrollment date outlined in the chart below.
- I am aware that my un-enrollment cost will be the loss of my deposit and a percentage of the annual tuition in accordance with the date I unenroll, for details See below:

If joining Emerging Sprouts later in the year, I will be responsible for my child’s prorated tuition per the timeline outlined above. Upon completion of this timeline, I understand that I am obligated for the full year’s tuition and that ESFS will make no refund or cancellation of yearly tuition for absence, withdrawal, or dismissal before the end of the school year.

3. In the event that my child separates from ESFS with an unpaid balance, I agree to pay attorney’s fees and related expenses should ESFS need to resort to collection.

4. I understand that tuition payments received after the 15th of the month may be subject to a late fee of \$75. Payments received past the 20th of the month can be charged a late fee plus 18% interest.

5. I understand that auxiliary fees in the amount of \$250 will be billed on July 15th, 2024, in addition to the annual tuition to cover the following: school materials, one ESFS tee-shirt, etc.

By signing below, I agree to items 1-5 of this Agreement and will return one copy to Emerging Sprouts Forest School within 72 hours to hold my child's space. I understand that this signed Agreement and non-refundable tuition deposit of (\$1050) will reserve a spot for my child. Failure to return this Agreement with the tuition deposit could result in the forfeit of my child's space for the 2024-2025 School Year.
